As at August 2020 these are: A requirement that people who are ill stay at home Robust hand and respiratory hygiene Enhanced cleaning arrangements Active engagement with NHS Test and Trace • Formal consideration of how to reduce contacts and maximise distancing between those in school. Prevention (full details of each points identified below available in guidance document via link above) 1) Minimise contact with individuals who are unwell by ensuring that those who have coronavirus (COVID-19) symptoms, or who have someone in their household who does, do not attend school. 2) Where recommended, use of face coverings in schools. 3) Clean hands thoroughly more often than usual. 4) Ensure good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach. 5) Introduce enhanced cleaning, including cleaning frequently touched surfaces often, using standard products such as detergents and bleach. 6) Minimise contact between individuals and maintain social distancing wherever possible. 7) Where necessary, wear appropriate personal protective equipment (PPE). Numbers 1 to 5 must be in place in all schools, all the time. **Response to any infection** 8) Engage with the NHS Test and Trace process. 9) Manage confirmed cases of coronavirus (COVID-19) amongst the school community. 10) Contain any outbreak by following local health protection team advice. Numbers 8 to 10 must be followed in every case where they are relevant

In addition to previous details 'Guidance as at Summer 2020' involving;

- minimising contact with individuals who are unwell by ensuring that those who have coronavirus symptoms, or who have someone in their household who does, do not attend childcare settings, schools or colleges
- cleaning hands more often than usual wash hands thoroughly for 20 seconds with running water and soap and dry them thoroughly or use alcohol hand rub or sanitiser ensuring that all parts of the hands are covered
- ensuring good respiratory hygiene promote the 'catch it, bin it, kill it' approach
- cleaning frequently touched surfaces often using standard products, such as detergents and bleach
- minimising contact and mixing by altering, as much as possible, the environment (such as classroom layout) and timetables (such as staggered break

Always make sure everyone is washing their hands with soap and water for at least 20 seconds or regularly using hand sanitiser across the school day, particularly:

• After coming into school; on way into a classroom; after break times; after sneezing or coughing; before and after handling or eating food; after going to the toilet; after significant hand touch contact with surfaces.

3 Clean hands thoroughly more often	Soap and running water or hand sanitiser as per guidance acceptable. CHS requires pupils to have their own sanitiser and Covid Kit as detailed in written and video comms. Sanitiser available in all classrooms and communal areas. Staff will be issued with their own hand sanitiser. Pupils expected to sanitise on entry and exit to classrooms and as detailed in guidance issued to all.

6 minimise contact between individuals and maintain social distancing wherever possible	Pupils are coming back to school in year group bubbles as per the communication made to parents, carers, pupils on 24 August 2020. This involves a staggered start and finish times to minimise contact across bubbles. Break time zones have been introduced and a staggered lunch time. Reduced food options with no food available at break and some at lunch time with set areas for each year group bubble. Significant emphasis in staff communications has been placed on 2m staff / adult distancing and modelling compliant behaviours. Teaching for learning advice we have given recommends teachers remaining at the front of their classroom 2m from pupils where possible. All classrooms are in rows. Pupils are required to be in seating plans which are stored for track and trace purposes by teachers via Edulink. This is accessible if required out of hours for close contact identification. Pupils are coming in PE kit on days when they have PE to prevent large numbers of pupils in small changing areas. Subject areas that would previously involve group work or practical work have their own risk assessment identifying risk reduction measures. There is a separate risk assessment for TAs who work closely or on a 121 with pupils. There is a significant one way system in place which we have called our lazy river. Other Key Recommendations from Guidance as at 14 September 2020

- Attendance we have and will continue to communicate that full attendance is required in school unless the child is unwell. Our attendance office will work with our families who may find this a challenge. Attendance policy updated APS leading.
- School workforce the expectation is that the workforce returns in full to school. Very few roles can be undertaken working from home in their entirety. Cams Hill School knows its staff well and is working with those who are anxious or who require further reassurance with regard to a safe return to work. Staff who are extremely clinically vulnerable are able to return with control measures in place as identified above. - Recruitment all recruitment will be compliant with guidance as overseen by Rachel Matthews DHT and Gemma Tullet, HR Supervisor.
- ITT trainees Jenny Lawrence oversees trainees with JRZ and MSY. Trainees will be treated as per the guidance for our staff workforce and be expected to follow all policies and protocols in place.

- **Catering** our kitchens are open in line with guidance with a reduced offer to ensure a reduction of queuing for pupils. Pupils get food from specific identified areas and are in a staggered lunch pattern within their bubble.

- School uniform we have returned to our full uniform for all pupils apart from on days when they have PE 9short term) to reduce pupil mixing in small changing room areas.
- Extra curricular activities We are hoping to provide year group based activities for pupils. This will be a more limited provision than pre Covid. - **Open Evening** this is now going to be a virtual event part pre recorded and part live. There will be the offer of some tours out of school hours run by SLT. SBG leading on protocols for these re masks, one parent, one prospective pupil and criteria for booking a tour (no prior knowledge of school; moving in to the area; SEN; LAC)

Section 3 - Curriculum, Behaviour and Pastoral Support.

- CHS will offer a broad, balanced and ambitious curriculum on full return of pupils in September 2020
- There is no intention to offer remote education until Government guidance may change directing us to do so
- Where remote education is offered it will be in line with guidance integrating a full curriculum offer for all pupils across all year groups.
- Subject specific risk assessments are in place following guidance in these areas.
