

Cams Hill School Online Safety Policy

1. Key Details

Designated Safeguarding Leads: Mrs A Potts (Assistant Headteacher), Mrs S Brooker (Inclusion and Safeguarding Lead), Mrs P Newman (Associate Assistant Headteacher), Miss A Kendall (Assistant Head of Year), Mr J Anderson (Assistant Head of Year), Mrs J Lawrence (Assistant Headteacher/Prevent) and Mr A Haines (SENDCO/CL for Learning Support Department).

Named Governor with lead responsibility: tbc

This policy will be reviewed *at least* annually. It will also be revised following any concerns and/or updates to national and local guidance or procedures.

2. Policy Aims

- This online safety policy has been written by Cams Hill School, involving staff, pupils and parents/carers, with specialist advice and input as required.
- It takes into account the DfE statutory guidance 'Keeping Children Safe in Education 2021'.
- The purpose of Cams Hill School Online Safety Policy is to:
 - Safeguard and protect all members of Cams Hill School community online.
 - Identify approaches to educate and raise awareness of online safety throughout the community.
 - Enable all staff to work safely and responsibly, to role model positive behaviour online and to manage professional standards and practice when using technology.
 - Identify clear procedures to use when responding to online safety concerns.
- Cams Hill School identifies that the issues classified within online safety are considerable, but can be broadly categorised into three areas of risk:
 - **Content:** being exposed to illegal, inappropriate or harmful material
 - **Contact:** being subjected to harmful online interaction with other users
 - Conduct: personal online behaviour that increases the likelihood of, or causes, harm.
 - Commerce: risks such as online gambling, inappropriate advertising, phishing and or financial scams. If you feel pupils or staff are at risk, please report it to the Anti-Phishing Working Group (https://apwg.org/reportphishing/)

3. Policy Scope

- Cams Hill School believes that online safety is an essential part of safeguarding and acknowledges its duty to ensure that all pupils and staff are protected from potential harm online.
- Cams Hill School identifies that the internet and associated devices, such as computers, tablets, mobile phones and games consoles, are an important part of everyday life.
- Cams Hill School believes that pupils should be empowered to build resilience and to develop strategies to manage and respond to risk online.
- This policy applies to all staff including the governing body, teachers, support staff, external contractors, visitors, volunteers and other individuals who work for, or provide services on behalf of the school (collectively referred to as 'staff' in this policy) as well as pupils and parents/carers.

• This policy applies to all access to the internet and use of technology, including personal devices, or where pupils, staff or other individuals have been provided with school issued devices for use offsite, such as a work laptops, tablets or mobile phones.

3.1 Links with other policies and practices

- This policy links with a number of other policies, practices and action plans including:

4. Monitoring and Review

- Cams Hill School will review this policy at least annually.
- The policy will also be revised following any national or local policy requirements, any child protection concerns or any changes to the technical infrastructure.
- We will ensure that we regularly monitor internet use and evaluate online safety mechanisms to ensure that this policy is consistently applied.
- To ensure they have oversight of online safety, the Headteacher will be informed of online safety concerns, as appropriate.
- The named Governor for safeguarding will report on a regular basis to the governing body on online safety incidents, including outcomes.
- Any issues identified will be incorporated into the school's action planning.

5. Roles and Responsibilities

- The school has appointed Mrs Sara Brooker as Designated Safeguarding Lead to be the online safety lead.
- Cams Hill School recognises that all members of the community have important roles and responsibilities to play with regards to online safety.

5.1 The Senior Leadership Team (SLT) will:

- Ensure that online safety is viewed as a safeguarding issue and that practice is in line with national and local recommendations and requirements.
- Ensure there are appropriate and up-to-date policies regarding online safety; Good Behaviour Policy, Staff Acceptable Use of ICT policy, which cover acceptable use of technology.
- Ensure that suitable and appropriate filtering and monitoring systems are in place.
- Work with technical staff to monitor the safety and security of school systems and networks.

- Ensure that online safety is embedded within a progressive whole school curriculum, which enables all pupils to develop an age-appropriate understanding of online safety.
- Support the Designated Safeguarding Lead by ensuring they have sufficient time and resources to fulfil their online safety responsibilities.
- Ensure there are robust reporting channels for the school community to access regarding online safety concerns, including internal, local and national support.
- Ensure that appropriate risk assessments are undertaken regarding the safe use of technology.
- Audit and evaluate online safety practice to identify strengths and areas for improvement.

5.2 The Designated Safeguarding Leads (DSL) will:

- Act as a named point of contact on all online safeguarding issues and liaise with other members of staff or other agencies, as appropriate.
- Keep up-to-date with current research, legislation and trends regarding online safety and communicate this with the school community, as appropriate.
- Ensure all members of staff receive regular, up-to-date and appropriate online safety training.
- Work with staff to coordinate participation in local and national events to promote positive online behaviour, such as Safer Internet Day.
- Ensure that online safety is promoted to parents, carers and the wider community, through a variety of channels and approaches.
- Maintain records of online safety concerns, as well as actions taken, as part of the schools safeguarding recording mechanisms.
- Monitor online safety incidents to identify gaps and trends, and use this data to update the education response, policies and procedures.
- Report online safety concerns, as appropriate, to the Senior Leadership Team and Governing Body.
- Work with the Senior Leadership Team to review and update online safety policies on a regular basis (at least annually) with stakeholder input.
- Meet regularly (*once a term*) with the governor with a lead responsibility for safeguarding and/or online safety.
- DSL to meet half termly with Head of ICT and IT Network Manager, to discuss any emerging online safety issues, any concerns that have been reported and outcomes and/or inputs to the curriculum to ensure pupils, staff and wider community are alerted to changes in online safety.

5.3 It is the responsibility of all members of staff to:

- Contribute to the development of online safety policies.
- Read and adhere to the Online Safety Policy and Staff Acceptable Use of ICT Policy.
- Take responsibility for the security of school systems and the data they use or have access to.
- Model good practice when using technology and maintain a professional level of conduct in their personal use of technology, both on and off site.
- Embed online safety education in curriculum delivery, wherever possible.
- Have an awareness of a range of online safety issues and how they may be experienced by the children in their care.
- Identify online safety concerns and take appropriate action by following the school's safeguarding policies and procedures.

- Know when and how to escalate online safety issues, including signposting to appropriate support, internally and externally.
- Take personal responsibility for professional development in this area.

5.4 It is the responsibility of staff managing the technical environment to:

- Provide technical support and perspective to the DSL and Senior Leadership Team, especially in the development and implementation of appropriate online safety policies and procedures.
- Implement appropriate security measures (including password policies and encryption) to ensure that the school's IT infrastructure/system is secure and not open to misuse or malicious attack, whilst allowing learning opportunities to be maximised.
- Ensure that the school's filtering policy is applied and updated on a regular basis; responsibility for its implementation is shared with the Senior Leadership Team.
- Report any filtering breaches to the DSL and Senior Leadership Team, as well as the school's Internet Service Provider or other services, as appropriate.
- Ensure that any safeguarding concerns, identified through monitoring or filtering breaches are reported to the DSL, in accordance with the school's safeguarding procedures.

5.5 It is the responsibility of pupils (at a level that is appropriate to their individual age, ability and vulnerabilities) to:

- Engage in age appropriate online safety education opportunities.
- Contribute to the development of online safety policies.
- Read and adhere to the school ICT Policy.
- Respect the feelings and rights of others both on and offline.
- Take responsibility for keeping themselves and others safe online.
- Seek help from a trusted adult, if there is a concern online, and support others that may be experiencing online safety issues.

5.6 It is the responsibility of parents and carers to:

- Read the school ICT Policy (available on the School website) and encourage their children to adhere to it.
- Support the school in their online safety approaches by discussing online safety issues with their children and reinforce appropriate, safe online behaviours at home.
- Role model safe and appropriate use of technology and social media.
- Identify changes in behaviour that could indicate that their child is at risk of harm online.
- Seek help and support from the school, or other appropriate agencies, if they or their child encounter risk or concerns online.
- Use school systems, such as learning platforms, and other network resources, safely and appropriately.
- Take responsibility for their own awareness in relation to the risks and opportunities posed by new and emerging technologies.

6. Education and Engagement Approaches

6.1 Education and engagement with pupils

- The school will establish and embed a progressive online safety curriculum throughout the whole school, to raise awareness and promote safe and responsible internet use amongst pupils by:
 - Ensuring education regarding safe and responsible use precedes internet access.
 - Including online safety in the PDLC, RSE and ICT curriculum, covering use both at school and home.
 - Reinforcing online safety messages whenever technology or the internet is in use.
 - Educating pupils in the effective use of the internet to research; including the skills of knowledge location, retrieval and evaluation.
 - Teaching pupils to be critically aware of the materials they read and show how to validate information before accepting its accuracy.
- The school will support pupils to read and understand the ICT Policy in a way which suits their age and ability by:
 - Displaying acceptable use posters in all rooms with internet access.
 - Informing pupils that network and internet use will be monitored for safety and security purposes and in accordance with legislation.
 - Rewarding positive use of technology by pupils.
 - Implementing appropriate peer education approaches.
 - Providing online safety education and training as part of the transition programme across the key stages and when moving between establishments.

6.1.1 Vulnerable Pupils

- Cams Hill School is aware that some pupils are considered to be more vulnerable online due to a range
 of factors. This may include, but is not limited to, children in care, children with Special Educational
 Needs and Disabilities (SEND) or mental health needs, children with English as an Additional Language
 (EAL) and children experiencing trauma or loss.
- Cams Hill School will ensure that differentiated and ability appropriate online safety education, access and support is provided to vulnerable pupils. New curriculum from 2020 informs and develops knowledge of current and ongoing E-Safety issues. This is to be reviewed bi-annually or when a new issue presents itself due to the changing nature of young people using technology for different reasons. See Annex 1 for what is covered in this document so far. The use of Senso.cloud software allows for teachers to effectively monitor all screens and manage lessons appropriately and support vulnerable pupils if necessary.
- Cams Hill School will seek input from specialist staff as appropriate, including the SENDCO and Designated Teacher (Looked After Children).

6.2 Training and engagement with staff

The School will:

- Provide and discuss the Online Safety Policy with all members of staff as part of induction.
- Provide up-to-date and appropriate online safety training for all staff on a regular basis, with at least annual updates (this will take place during CPL training and regular briefing updates).

This will cover the potential risks posed to pupils (Content, Contact, Conduct and Commerce) as well as our professional practice expectations.

- Make staff aware that school systems are monitored and activity can be traced to individual users; staff
 will be reminded to behave professionally and in accordance with school policies when accessing school
 systems and devices.
- Make staff aware that their online conduct out of school, including personal use of social media, could have an impact on their professional role and reputation within school.
- Highlight useful educational resources and tools which staff should use, according to the age and ability of the pupils.
- Ensure all members of staff are aware of the procedures to follow regarding online safety concerns affecting pupils, colleagues or other members of the school community.

6.3 Awareness and engagement with parents and carers

- Cams Hill School recognises that parents and carers have an essential role to play in enabling children to become safe and responsible users of the internet and associated technologies.
- The School will build a partnership approach to online safety with parents and carers by:
 - Providing information and guidance on online safety in a variety of formats. This will include offering specific online safety awareness training and highlighting online safety at other events such as parent evenings, transition events and PDLC.
 - Drawing their attention to the School's ICT Policy and expectations in newsletters, via the school's social media, prospectus and on our website.
 - Recommending that they read the online safety information as part of joining our school, for example, within our safeguarding webpage.
 - Recommending that they read the school ICT Policy and discuss its implications with their children.

7. Reducing Online Risks

- Cams Hill School recognises that the internet is a constantly changing environment with new apps, devices, websites and material emerging at a rapid pace. We will:
 - Regularly review the methods used to identify, assess and minimise online risks.
 - Examine emerging technologies for educational benefit and undertake appropriate risk assessments before use in school is permitted.
 - Ensure that appropriate filtering and monitoring is in place and take all reasonable precautions to ensure that users can only access appropriate material.
 - Due to the global and connected nature of the internet, it is not possible to guarantee that unsuitable material cannot be accessed via a school computer or device.
- All members of the school community are made aware of the school's expectations regarding safe and appropriate behaviour online and the importance of not posting any content, comments, images or videos which could cause harm, distress or offence to members of the community. This is clearly outlined in the school's Staff Acceptable Use of ICT Policy, ICT Policy and highlighted through a variety of education and training approaches.

8. Safer Use of Technology

8.1 Classroom Use

- Cams Hill School uses a wide range of technology. This includes access to:
 - Computers, laptops and other digital devices
 - Internet which may include search engines and educational websites
 - School learning platform/intranet
 - Email
 - Games consoles and other games-based technologies
 - Digital cameras, web cams and video cameras
- All school owned devices will be used in accordance with the school's Staff Acceptable Use of ICT Policy and ICT Policy with appropriate safety and security measures in place. Classroom and mobile devices are filtered via the Senso.cloud system, which is constantly updated and performs heuristic scanning to detect threats not yet catalogued by the system.
- In the classroom, all PCs are monitored using Senso.cloud, which constantly looks for inappropriate phrases, words and images within both student-created and online-accessed material. Scanning is also performed to detect combinations of words which may alert the school to a safeguarding issue. Alerts are sent to both the classroom teacher and ICT Network team if these are detected.
- Members of staff will always evaluate websites, tools and apps fully before use in the classroom or recommending for use at home.
- The school will use age appropriate search tools including Google Safe Search, following an informed risk assessment, to identify which tool best suits the needs of our community.
- The school will ensure that the use of internet-derived materials, by staff and pupils, complies with copyright law and acknowledge the source of information.
- Supervision of pupils will be appropriate to their age and ability.

Key Stage 3 and 4

 Pupils will be appropriately supervised when using technology, according to their ability and understanding.

8.2 Managing Internet Access

- The school will maintain a written record of users who are granted access to the school's devices and systems. This is supplemented with a comprehensive logging system at the firewall and filters, giving details of access directly linked to pupil and staff usernames.
- All staff, pupils and visitors will read and sign an ICT Policy, Staff Acceptable Use of ICT Policy before being given access to the school computer system, IT resources or internet.

8.3 Filtering and Monitoring

8.3.1 Decision Making

• Cams Hill School Governors and Senior Leadership Team have ensured that the school has age and ability appropriate filtering and monitoring in place, to limit children's exposure to online risks.

- The Governors and Senior Leadership Team are aware of the need to prevent 'over blocking', as that may unreasonably restrict what children can be taught, with regards to online activities and safeguarding.
- The school's decision regarding filtering and monitoring has been informed by a risk assessment, taking into account our school's specific needs and circumstances.
- Changes to the filtering and monitoring approach will be risk assessed by staff with educational and technical experience and, where appropriate, with consent from the Senior Leadership Team; all changes to the filtering policy are logged and recorded.
- The Senior Leadership Team will ensure that regular checks are made to ensure that the filtering and monitoring methods are effective and appropriate.
- All members of staff are aware that they cannot rely on filtering and monitoring alone to safeguard pupils; effective classroom management and regular education about safe and responsible use is essential.

8.3.2 Filtering

- The school uses educational broadband connectivity through Southern Communications.
- The school uses Senso.cloud and Securly filtering at the firewall which blocks sites which can be categorised as: pornography, racial hatred, extremism, gaming and sites of an illegal nature. The school filtering system blocks all sites on the <u>Internet Watch Foundation</u> (IWF) list.
- The school works with Senso.cloud and Securly to ensure that our filtering policy is continually reviewed.

8.3.3 Dealing with Filtering breaches

- The school has a clear procedure for reporting filtering breaches.
 - If pupils discover unsuitable sites, they will be required to report it immediately to a member of staff who will note the time and workstation for later review, then close the site.
 - The member of staff will report the concern (including the URL of the site if possible) to the Designated Safeguarding Lead and/or technical staff.
 - The breach will be recorded and escalated as appropriate.
 - Parents/carers will be informed of filtering breaches involving their child.
- Any material that the school believes is illegal will be reported immediately to the appropriate agencies, such as: IWF, Hampshire Police or CEOP.

8.3.4 Monitoring

- The school will appropriately monitor internet use on all school owned or provided internet enabled devices. This is achieved by:
 - Pupils not being allowed in ICT rooms unsupervised by members of staff.
 - Compulsory internet filtering and logging on all student accessible devices.
 - Senso.cloud console on all student accessible PCs, logging all words typed, not just internet access.
 - Log files reviewed from Senso.cloud at the end of the day and alerts sent to technicians throughout the school day.
- The school has a clear procedure for responding to concerns identified via monitoring approaches; concerns and trends in monitoring patterns will be reported to the appropriate DSL, Head of ICT and Director of IT Services.
- Staff are trained to record video tutorials, meetings and classes (Zoom/Teams etc) undertaken during periods of home learning.

• All users will be informed that use of school systems can be monitored and that all monitoring will be in line with GDPR, human rights and privacy legislation.

8.4 Managing Personal Data Online

- Personal data will be recorded, processed, transferred and made available online in accordance with General Data Protection Regulations (GDPR) and Data Protection legislation.
 - Full information can be found in the Data Protection Policy.

8.5 Security and Management of Information Systems

- The school takes appropriate steps to ensure the security of our information systems, including:
 - Virus protection being updated regularly.
 - Encryption for personal data sent over the internet or taken off site (such as via portable media storage) or access via appropriate secure remote access systems.
 - Not using portable media without specific permission; portable media will be checked by an antivirus/malware scan before use. All staff are expected to encrypt portable storage devices and have been given training on how to do so.
 - Not downloading unapproved software to work devices or opening unfamiliar email attachments.
 - Regularly checking files held on the school's network,
 - The appropriate use of user logins and passwords to access the school network.
 Specific user logins and passwords will be enforced for all.
 - All users are expected to log off or lock their screens/devices if systems are unattended.
 - Further information about technical environment safety and security can be found in the staff and pupil acceptable use of ICT policies.

8.5.1 Password policy

- All members of staff will have their own unique username and private passwords to access school systems; members of staff are responsible for keeping their password private.
- From Year 7 all pupils are provided with their own unique username and private passwords to access school systems; pupils are responsible for keeping their password private.
- We require all users to:
 - Use strong passwords for access into our system.
 - Change their passwords every 3 months.
 - Always keep their password private; users must not share it with others or leave it where others can find it.
 - Not to login as another user at any time.

8.6 Managing the Safety of the School Website

- The school will ensure that information posted on our website meets the requirements as identified by the Department for Education (DfE).
- The school will ensure that our website complies with guidelines for publications including: accessibility; data protection; respect for intellectual property rights; privacy policies and copyright.
- Staff or pupils' personal information will not be published on our website; the contact details on the website will be the school address, email and telephone number.

- The administrator account for the school website will be secured with an appropriately strong password.
- The school will post appropriate information about safeguarding, including online safety, on the school website for members of the community.

8.7 Publishing Images and Videos Online

• The school will ensure that all images and videos shared online are used in accordance with the associated polices, including (but not limited to): GDPR Policy, Staff Acceptable Use of ICT Policy, Good Behaviour Policy, Social Media Policy and use of personal devices and mobile phones.

8.8 Managing Email

- Access to school email systems will always take place in accordance with Data Protection legislation and in line with other school policies, including: Code of Conduct, Staff Acceptable Use of ICT Policy and Good Behaviour Policy.
 - The forwarding of any chain messages/emails is not permitted. Spam or junk mail will be blocked and reported to the email provider.
 - Any electronic communication which contains sensitive or personal information will only be sent using secure and encrypted email.
 - School email addresses and other official contact details will not be used for setting up personal social media accounts.
- Members of the school community will immediately tell the DSL or Director of IT Services if they receive offensive communication, and this will be recorded in the school safeguarding files/records.
- Excessive social email use can interfere with teaching and learning and will be restricted; school email accounts are automatically monitored and the contents will be searched if concerns are raised.
- The school will have a dedicated email for reporting wellbeing and pastoral issues. This inbox will be managed by designated and trained staff dsls@camshill.com

8.8.1 Staff

- The use of personal email addresses by staff for any official school business is not permitted.
 - All members of staff are provided with a specific school email address, to use for all official communication.
- Members of staff are encouraged to have an appropriate work life balance when responding to email, especially if communication is taking place between staff and pupils and parents.

8.8.2 Pupils

- Pupils will use school provided email accounts for educational purposes.
- Pupils will sign an AUP and will receive education regarding safe and appropriate email etiquette before access is permitted.

8.9 Management of Learning Platforms

- Cams Hill School uses Cams Hill Online Classroom (CHOC) as its official learning platform.
- Leaders and staff will regularly monitor the usage of the Learning Platform (LP) in all areas, in particular, message and communication tools and publishing facilities.

- Only current members of staff, pupils and parents will have access to the LP. When staff and/or pupils' leave the school, their account or rights to specific school areas will be disabled or transferred to their new establishment.
- Pupils and staff will be advised about acceptable conduct and use when using the LP.
- All users will be mindful of copyright and will only upload appropriate content onto the LP.
- Any concerns about content on the LP will be recorded and dealt with in the following ways:
 - The user will be asked to remove any material deemed to be inappropriate or offensive.
 - If the user does not comply, the material will be removed by the site administrator.
 - Access to the LP for the user may be suspended.
 - The user will need to discuss the issues with a member of leadership before reinstatement.
 - A pupil's parent/carer may be informed.
 - If the content is considered to be illegal, then the school will respond in line with existing child protection procedures.
- Pupils may require editorial approval from a member of staff. This may be given to the pupil to fulfil a specific aim and may have a limited time frame.
- A visitor may be invited onto the LP by a member of the leadership team; in this instance, there may be an agreed focus or a limited time slot.

8.10 Management of Applications which Record Children's Progress

- The school uses SIMS, ClassCharts and Edulink One to track pupils' progress and share appropriate information with parents and carers.
- The Headteacher is ultimately responsible for the security of any data or images held of children. As such, they will ensure that tracking systems are appropriately risk assessed prior to use, and that they are used in accordance with GDPR and data protection legislation
- To safeguard data:
 - School devices will be appropriately encrypted if taken off site to reduce the risk of a data security breach in the event of loss or theft.
 - All users will be advised regarding safety measures, such as using strong passwords and logging out of systems.
 - Parents and carers will be informed of the expectations regarding safe and appropriate use, prior to being given access; for example, not sharing passwords or images.

9. Remote Learning (Including Live Lessons)

9.1 Live Online Teaching

- Live online teaching is an important part of this overall package for pupils of all ages. Interaction with a teacher is an important part of the learning process and, whilst online contact cannot replicate face to face contact, live sessions are particularly helpful as they allow contemporaneous communication, with pupils able to respond to staff questions and vice versa.
- Live contact is an important part of pastoral support and provides pupils with a direct interface with a familiar trusted figure at a time of significant change and uncertainty.
- Live classes also give pupils the opportunity to interact with peers and maintain important social connections during a period when they could otherwise become isolated. However, it should be

remembered that live online teaching remains 'one tool in the box' and, for the reasons set out above, it should be balanced alongside learning opportunities in a range of other formats.

- Members of the Cams Hill School community sign into Zoom via Single Sign-On using their Cams Hill email address and password. This ensures that teachers know who is in their online classroom at all times, keeping pupils safe from online intruders.
- In order to safeguard both pupils and staff, live online sessions must be conducted following the protocols set out below.

9.2 Protocols for staff in relation to guided home learning:

- Only use school approved platforms; do not use social media in communicating with pupils.
- Reinforce online safety messages regularly in your teaching.
- Bear in mind the current circumstances and how they are affecting children and families when setting expectations of pupils.
- Consider online safety when sharing resources vet websites and videos/apps/software carefully and bear in mind that the home environment will not have the same content filtering systems as at school. If introducing new apps and resources, ensure these meet GDPR requirements. Contact your Line Manager/Director of IT Services for further guidance.
- If concerned about online safety/resources, check with IT support.
- Ensure that passwords and secure information such as log-ins for SIMS/EDULINK/ClassCharts are kept confidential.
- Adhere to copyright and GDPR guidelines.
- Continue to look out for signs that a child may be at risk which may differ from typical triggers in a school environment. Report any concerns to the DSL without delay in the usual way.
- Do not provide pupils or parents with personal contact details email, home or mobile numbers, details of web-based identities etc.
- Do not arrange to meet pupils or ask them to deliver work to your home.
- Remain professional and objective in all email and other forms of correspondence.

9.3 Staff responsibilities to live online teaching:

- Teachers must use the waiting room function on Zoom and should admit pupils only if they recognise them as members of Cams Hill School community.
- Keep a record/log of live online lessons date and time, attendance, what was covered, any incidents. Any serious incidents should be reported in the usual manner depending on the nature of the issue.
- Maintain professional conduct during live streaming dress appropriately, consider your surroundings (background, other household members who may come into view etc) and blur if necessary, and remember that your microphone may be on.
- Maintain the same boundaries and insist on the same standard of behaviour as in a school setting. Make specific protocols clear at the outset, e.g. muting of microphones at appropriate times, use of the chat function etc.
- 1:1 teaching and guidance are an important part of school provision for some pupils and this should be maintained as far as possible during guided home learning.

9.4 Reporting an issue for staff:

- Any child protection or safeguarding concern must be reported to the DSL without delay.
- Concerns about the safety of procedures, behaviours or use of technology should be referred to the DSL and the Director of IT Services.

- Routine queries about the use of apps or online materials should be addressed to your Line Manager or IT Support depending on the nature of the issue.
- UK Safer Internet Centre's Professionals Online Safety Helpline is a good source of external advice.

9.5 Protocols for pupils in relation to guided home learning:

- Always log on through your CHOC account and use your Cams Hill School email for school business.
- Do not make recordings, take screenshots/screengrabs or photographs, or store footage of teachers or other pupils.
- Be aware that all live online sessions will be recorded by the school.
- Dress appropriately for online lessons.
- Ensure that you have a safe and appropriate place to participate from. Blur your background if necessary.
- Follow the school rules for conduct during online lessons as if you were in school.
- Do not undermine in any way the technology used to offer video lessons.
- If you have concerns about online safety, or if you feel you are being bullied, talk to someone you trust, your Form Tutor would be a good choice.

10. Social Media

10.1 Expectations

- The expectations regarding safe and responsible use of social media apply to all members of Cams Hill School community.
- The term social media may include (but is not limited to): blogs, wikis, social networking sites, forums, bulletin boards, online gaming, apps, video/photo sharing sites, chatrooms and instant messenger.
- All members of Cams Hill School community are expected to engage in social media in a positive, safe and responsible manner, at all times.
 - All members of Cams Hill School community are advised not to publish specific and detailed private thoughts, concerns, pictures or messages on any social media services, especially content that may be considered threatening, hurtful or defamatory to others.
- The school will control pupil and staff access to social media whilst using school provided devices and systems on site.
 - The use of social media during school hours for personal use is not permitted for pupils.
 - Inappropriate or excessive use of social media during school/work hours or whilst using school devices may result in disciplinary or legal action and/or removal of internet facilities.
- Concerns regarding the online conduct of any member of Cams Hill School community on social media, should be reported to the school and will be managed in accordance with our Anti-Bullying, Good Behaviour and Child Protection policies.

10.2 Staff Personal Use of Social Media

- The safe and responsible use of social networking, social media and personal publishing sites will be discussed with all members of staff as part of staff induction and will be revisited and communicated via regular staff training opportunities.
- Safe and professional behaviour will be outlined for all members of staff (including volunteers) as part of the school Code of Conduct within the Staff Acceptable Use of ICT and Social Media Policy.

10.2.1 Reputation

- All members of staff are advised that their online conduct on social media can have an impact on their role and reputation within school. Civil, legal or disciplinary action may be taken if they are found to bring the profession or institution into disrepute, or if something is felt to have undermined confidence in their professional abilities.
- All members of staff are advised to safeguard themselves and their privacy when using social media sites. Advice will be provided to staff via staff training and by sharing appropriate guidance and resources on a regular basis. This will include (but is not limited to):
 - Setting the privacy levels of their personal sites as strictly as they can.
 - Being aware of location sharing services.
 - Opting out of public listings on social networking sites.
 - Logging out of accounts after use.
 - Keeping passwords safe and confidential.
 - Ensuring staff do not represent their personal views as that of the school.
- Members of staff are encouraged not to identify themselves as employees of Cams Hill School on their personal social networking accounts. This is to prevent information on these sites from being linked with the school and also to safeguard the privacy of staff members.
- All members of staff are encouraged to carefully consider the information, including text and images, they share and post online and to ensure that their social media use is compatible with their professional role and is in accordance with school's policies and the wider professional and legal framework.
 - Information and content that staff members have access to as part of their employment, including
 photos and personal information about pupils and their family members or colleagues will not be
 shared or discussed on social media sites.
- Members of staff will notify the Senior Leadership Team immediately if they consider that any content shared on social media sites conflicts with their role in the school.

10.2.2 Communicating with pupils and parents and carers

- All members of staff are advised not to communicate with or add as 'friends' any current or past pupils or current or past pupils' family members via any personal social media sites, applications or profiles.
 - Any pre-existing relationships or exceptions that may compromise this will be discussed with Designated Safeguarding Lead and/or the Headteacher.
 - If ongoing contact with pupils is required once they have left the school roll, members of staff will be expected to use existing alumni networks or use official school provided communication tools.
- Staff should exercise caution and not use personal social media accounts to make contact with pupils or parents, nor should any contact be accepted. Staff are to adhere to the Social Media Policy.
- Any communication from pupils and parents received on personal social media accounts will be reported to the schools Designated Safeguarding Lead.

10.3 Pupils' Personal Use of Social Media

- Safe and appropriate use of social media will be taught to pupils as part of an embedded and progressive education approach, via age appropriate sites and resources.
- The school is aware that many popular social media sites state that they are not for children under the age of 13, therefore the school will not create accounts specifically for children under this age.
- Any concerns regarding pupils' use of social media, both at home and at school, will be dealt with in accordance with existing school policies including Anti-Bullying and Good Behaviour. Concerns will also

be raised with parents/carers as appropriate, particularly when concerning underage use of social media sites or tools.

- Pupils will be advised:
 - To consider the benefits and risks of sharing personal details on social media sites which could identify them and/or their location. Examples could include real/full name, address, mobile or landline phone numbers, school attended, other social media contact details, email addresses, full names of friends/family, specific interests and clubs.
 - To only approve and invite known friends on social media sites and to deny access to others by making profiles private/protected.
 - Not to meet any online friends without a parent/carer or other responsible adult's permission and only when a trusted adult is present.
 - To use safe passwords.
 - To use social media sites which are appropriate for their age and abilities.
 - How to block and report unwanted communications and report concerns both within school and externally.

10.4 Official Use of Social Media

• Cams Hill School official social media channels are:

• The official use of social media sites, by the school, only takes place with clear educational or community engagement objectives, with specific intended outcomes.

- The official use of social media as a communication tool has been formally risk assessed and approved by the Headteacher.
- Senior Leadership Team have access to account information and login details for the social media channels via the Director of IT Services, in case of emergency, such as staff absence.
- Official school social media channels have been set up as distinct and dedicated social media sites or accounts for educational or engagement purposes only.
 - Staff use school provided email addresses to register for and manage any official school social media channels.
 - Official social media sites are suitably protected and, where possible, linked to the school website.
 - Public communications on behalf of the school will, where appropriate and possible, be read and agreed by at least one other colleague.
- Official social media use will be conducted in line with existing policies, including: Anti-bullying, Staff Acceptable us of ICT, Data Protection Policy, Use of Social Media Policy and Child Protection Policy.
 - All communication on official social media platforms will be clear, transparent and open to scrutiny.
- Parents, carers and pupils will be informed of any official social media use, along with expectations for safe use and action taken to safeguard the community.
 - Social media tools which have been risk assessed and approved as suitable for educational purposes will be used.
 - Any official social media activity involving pupils will be moderated by the school where possible.
- Parents and carers will be informed of any official social media use with pupils and written parental consent will be obtained, as required.
- The school will ensure that any official social media use does not exclude members of the community who are unable or unwilling to use social media channels.

10.4.1 Staff expectations

- Members of staff who follow and/or like the school social media channels will be advised to use dedicated professional accounts, where possible, to avoid blurring professional boundaries.
- If members of staff are participating in online social media activity as part of their capacity as an employee of the school, they will:
 - Sign the school's Social Media Policy and Staff Acceptable Use of ICT Policy.
 - Be professional at all times and aware that they are an ambassador for the school.
 - Disclose their official role and/or position, but make it clear that they do not necessarily speak on behalf of the school.
 - Be responsible, credible, fair and honest at all times and consider how the information being published could be perceived or shared.
 - Always act within the legal frameworks they would adhere to within the workplace, including: Libel, Defamation, Confidentiality, Copyright, GDPR and Equalities laws.
 - Ensure that the appropriate consent has been given by parents before posting images on the school's official social media channels.
 - Not disclose information, make commitments or engage in activities on behalf of the school unless they are authorised to do so.
 - Not engage with any direct or private messaging with current or past pupils who are under the age of 18, as per the school's Social Media Policy.

- Exercise caution when having contact with or accepting 'friend' requests through social media with parents so as not to compromise the school's reputation or school information – refer to Social Media Policy.
- Inform their Line Manager, the Designated Safeguarding Lead and/or the Headteacher of any concerns, such as criticism, inappropriate content or contact from pupils.

11. Use of Personal Devices and Mobile Phones

• Cams Hill School recognises that personal communication through mobile technologies is an accepted part of everyday life for pupils, staff and parents/carers, but technologies need to be used safely and appropriately within school.

11.1 Expectations

- All use of personal devices and mobile phones will take place in accordance with the law and other appropriate school policies, including but not limited to: Anti-Bullying, Good Behaviour and Child Protection and Safeguarding Policies.
- Electronic devices of any kind that are brought onto site are the responsibility of the user at all times.
 - All members of Cams Hill School community are advised to take steps to protect their mobile phones or devices from loss, theft or damage; the school accepts no responsibility for the loss, theft or damage of such items on school premises.
 - All members of Cams Hill School community are advised to use passwords/pin numbers to ensure that unauthorised calls or actions cannot be made on their phones or devices; passwords and pin numbers should be kept confidential and mobile phones and personal devices should not be shared.
- Mobile phones and personal devices are not permitted to be used by pupils on the school site.
- The sending of abusive or inappropriate messages/ content via mobile phones or personal devices is forbidden by any member of the community; any breaches will be dealt with as part of our Good Behaviour policy.
- All members of Cams Hill School community are advised to ensure that their mobile phones and personal devices do not contain any content which may be considered to be offensive, derogatory or would otherwise contravene the school Good Behaviour or Child Protection and Safeguarding policies.

11.2 Staff Use of Personal Devices and Mobile Phones

- Members of staff will ensure that use of personal phones and devices takes place in accordance with the law, as well as, relevant school policy and procedures, such as: Data Protection Policy, Child Protection Policy, Safeguarding Policy and Staff Acceptable Use of ICT Policy.
- Staff will be advised to:
 - Keep mobile phones and personal devices in a safe and secure place during lesson time.
 - Keep mobile phones and personal devices switched off or switched to 'silent' mode during lesson times.
 - Ensure that Bluetooth or other forms of communication (such as 'airdrop') are hidden or disabled during lesson times.
 - Not use personal devices during teaching periods, unless written permission has been given by the Headteacher, such as in emergency circumstances.

- Ensure that any content brought onto site via mobile phones and personal devices is compatible with their professional role and expectations.
- Members of staff are not permitted to use their own personal phones or devices for contacting pupils or parents and carers.
 - Unless there is no other way to contact the parent/carer/pupil.
 - Any pre-existing relationships which could undermine this will be discussed with the Designated Safeguarding Lead/Headteacher.
- Staff will not use personal devices, such as mobile phones, tablets or cameras:
 - To take photos or videos of pupils and will only use work-provided equipment for this purpose.
 - Directly with pupils, and will only use work-provided equipment during lessons/educational activities.
 - Exceptions to this policy may be made, eg on trips for designated members of staff. In this case the
 member of staff will be expected to upload media directly to the school network or cloud systems
 and then remove all media from their device within 24 hours of their return.
- If a member of staff breaches the school policy, action will be taken in line with the Good Behaviour Policy, Staff Acceptable Use of ICT Policy, Social Media Policy, Child Protection and Safeguarding Policies.
 - If a member of staff is thought to have illegal content saved or stored on a mobile phone or personal device or have committed a criminal offence, the police will be contacted.

11.3 Pupils' Use of Personal Devices and Mobile Phones

- Pupils will be educated regarding the safe and appropriate use of personal devices and mobile phones and will be made aware of boundaries and consequences.
- Cams Hill School expects pupils' personal devices and mobile phones to be switched off and out of sight while at school.
- If a pupil needs to contact his/her parents or carers they will be allowed to use a phone at reception. Parents are advised to contact their child via the school office during school hours.
- If members of staff have an educational reason to allow children to use their mobile phones or personal devices as part of an educational activity, it will only take place when approved by the Senior Leadership Team.
- Mobile phones and personal devices must not be taken into examinations.
 - Pupils found in possession of a mobile phone or personal device during an exam will be reported to the appropriate examining body. This may result in the pupil's withdrawal from either that examination or all examinations.
- If a pupil breaches the school policy, the phone or device will be confiscated and will be held in a secure place.
 - School staff will confiscate a pupil's mobile phone or device if the device is seen or they believe it is being used to contravene the school's Good Behaviour Policy or Anti Bullying Policy or could contain youth produced sexual imagery (sexting).
 - Searches of mobile phones or personal devices will only be carried out in accordance with the school's policy. <u>www.gov.uk/government/publications/searching-screening-and-confiscation</u>
 - Pupils' mobile phones or devices may be searched by a member of the Senior Leadership Team.
 Content may be deleted or requested to be deleted, if it contravenes school policies.
 - Mobile phones and devices that have been confiscated will be released to parents or carers 3 days from confiscation.

 If there is suspicion that material on a pupil's personal device or mobile phone may be illegal or may provide evidence relating to a criminal offence, the device will be handed over to the police for further investigation.

11.4 Visitors' Use of Personal Devices and Mobile Phones

- Parents, carers and visitors (including volunteers and contractors) must use their mobile phones and personal devices in accordance with the school's Staff Acceptable Use of ICT Policy and other associated policies, such as: Anti-bullying, Good Behaviour, Safeguarding and Child Protection Policies.
- The school will ensure appropriate signage and information is provided to inform parents, carers and visitors of expectations of use.
- Members of staff are expected to challenge visitors if they have concerns and will always inform the Designated Safeguarding Lead of any breaches of school policy.

11.5 Officially Provided Mobile Phones and Devices

- Selected members of staff will be issued with a work phone number and email address, where contact with pupils or parents/carers is required.
- School mobile phones and devices will be suitably protected via a passcode/password/pin and must only be accessed or used by members of staff.
- School mobile phones and devices will always be used in accordance with the Acceptable Use of ICT Policy and other relevant policies.
- Teaching staff will be issued with a school-supplied iPad. This is centrally managed via inTune and Apple School Manager and protected with an appropriate PIN.

12. Responding to Online Safety Incidents and Concerns

- All members of the school community will be made aware of the reporting procedure for online safety concerns, including: breaches of filtering, youth produced sexual imagery (sexting), cyberbullying and illegal content.
- All members of the community must respect confidentiality and the need to follow the official school procedures for reporting concerns.
 - Pupils, parents and staff will be informed of the school's complaints procedure and staff will be made aware of the whistleblowing procedure.
- The school requires staff, parents, carers and pupils to work in partnership to resolve online safety issues.
- After any investigations are completed, the school will debrief, identify lessons learnt and implement any policy or curriculum changes as required.
- If the school is unsure how to proceed with an incident or concern, the DSL will seek advice from the Local Authority Designated Officer (LADO).
- Where there is suspicion that illegal activity has taken place, the school will contact the LADO or Hampshire Police using 101, or 999 if there is immediate danger or risk of harm.
- If an incident or concern needs to be passed beyond the school community (for example if other local schools are involved or the public may be at risk), the school will speak with Hampshire Police and/or the LADO first, to ensure that potential investigations are not compromised.

12.1 Concerns about Pupils' Welfare

- The DSL will be informed of any online safety incidents involving safeguarding or child protection concerns.
 - The DSL will record these issues in line with the School's Child Protection Policy.
- The DSL will ensure that online safety concerns are escalated and reported to relevant agencies in line with the Hampshire Safeguarding Children Partnership (HSCP) thresholds and procedures.
- The school will inform parents and carers of any incidents or concerns involving their child, as and when required.

12.2 Staff Misuse

- Any complaint about staff misuse will be referred to the Headteacher, in line with the Whistle Blowing Policy and Child Protection Policy.
- Any allegations regarding a member of staff's online conduct will be discussed with the LADO (Local Authority Designated Officer).
- Appropriate action will be taken in accordance with the Good Behaviour Policy and Code of Conduct Policy.

13. Procedures for Responding to Specific Online Incidents or Concerns

13.1 Youth Produced Sexual Imagery or "Sexting"

- Cams Hill School recognises youth produced sexual imagery (known as "sexting") as a safeguarding issue; therefore, all concerns will be reported to and dealt with by the DSL.
- The school will follow the advice as set out in the non-statutory UKCCIS guidance: <u>'Sexting in schools and</u> <u>colleges: responding to incidents and safeguarding young people'</u> and Local Safeguarding Children Board guidance: 'Responding to youth produced sexual imagery'.
- Cams Hill School will ensure that all members of the community are made aware of the potential social, psychological and criminal consequences of 'sexting' by implementing preventative approaches, via a range of age and ability appropriate educational methods.
- The school will ensure that all members of the community are aware of sources of support regarding youth produced sexual imagery.

13.1.1 Dealing with 'Sexting'

- If the school are made aware of an incident involving the creation or distribution of youth produced sexual imagery, the school will:
 - Immediately notify the DSL.
 - Store the device securely.
- If an indecent image has been taken or shared on the school network or devices, the school will:
 - Take action to block access to all users and isolate the image.
 - Carry out a risk assessment which considers any vulnerability of the pupil(s) involved; including carrying out relevant checks with other agencies.
 - Inform parents and carers, if appropriate, about the incident and how it is being managed.
 - Make a referral to Specialist Children's Services and/or the Police, as appropriate.

- Provide the necessary safeguards and support for pupils, such as offering counselling or pastoral support.
- Implement appropriate sanctions in accordance with the school's Good Behaviour Policy but taking care not to further traumatise victims where possible.
- Consider the deletion of images in accordance with the UKCCIS: <u>'Sexting in schools and colleges:</u> responding to incidents and safeguarding young people' guidance.
 Images will only be deleted once the school has confirmed that other agencies do not need to be involved; and are sure that to do so would not place a child at risk or compromise an investigation.
- Review the handling of any incidents to ensure that best practice was implemented; the Senior Leadership Team will also review and update any procedures, where necessary.
- The school will take action regarding youth produced sexual imagery, regardless of whether the incident took place on or off school premises, using school or personal equipment.
- The school will not:
 - View any images suspected of being youth produced sexual imagery, unless there is no other possible option, or there is a clear need or reason to do so.
 In this case, the image will only be viewed by the DSL and their justification for viewing the image.
 - In this case, the image will only be viewed by the DSL and their justification for viewing the image will be clearly documented.
 - Send, share, save or make copies of content suspected to be an indecent image of children (ie youth produced sexual imagery) and will not allow or request pupils to do so.

13.2 Online Child Sexual Abuse and Exploitation

- Cams Hill School will ensure that all members of the community are aware of online child sexual abuse, including: exploitation and grooming, the consequences, possible approaches which may be employed by offenders to target children, and how to respond to concerns.
- Cams Hill School recognises online child sexual abuse as a safeguarding issue and, as such, all concerns will be reported to and dealt with by the DSL.
- The school will implement preventative approaches for online child sexual abuse via a range of age and ability appropriate education for pupils, staff and parents/carers.
- The school will ensure that all members of the community are aware of the support available regarding online child sexual abuse, both locally and nationally.

13.2.1 Dealing with Online Child Sexual Abuse and Exploitation

- If the school are made aware of an incident involving online sexual abuse of a child, the school will:
 - Immediately notify the Designated Safeguarding Lead.
 - Store any devices involved securely.
 - Immediately inform Hampshire police via 101 (or 999 if a child is at immediate risk).
 - Carry out a risk assessment which considers any vulnerabilities of pupil(s) involved (including carrying out relevant checks with other agencies).
 - Inform parents/carers about the incident and how it is being managed.
 - Make a referral to Children's Services (if required/appropriate).
 - Provide the necessary safeguards and support for pupils, such as, offering counselling or pastoral support.
 - Review the handling of any incidents to ensure that best practice is implemented; Senior Leadership Team will review and update any management procedures, where necessary.

- The school will take action regarding online child sexual abuse, regardless of whether the incident took place on or off school premises, using school or personal equipment.
 - Where possible pupils will be involved in decision making and, if appropriate, will be empowered to report concerns such as via the Click CEOP report: <u>www.ceop.police.uk/safety-centre/</u>
- If the school is unclear whether a criminal offence has been committed, the Designated Safeguarding Lead will obtain advice immediately through the LADO or Hampshire Police.
- If the school is made aware of intelligence or information which may relate to child sexual exploitation (on or offline), it will be passed through to Hampshire Police by the DSL.
- If pupils at other schools are believed to have been targeted, the school will seek support from Hampshire Police and/or the LADO first to ensure that potential investigations are not compromised.

13.3 Indecent Images of Children (IIOC)

- Cams Hill School will ensure that all members of the community are made aware of the possible consequences of accessing Indecent Images of Children (IIOC).
- The school will take action regarding IIOC on school equipment and/or personal equipment, even if access took place off site.
- The school will take action to prevent accidental access to IIOC by using an Internet Service Provider (ISP) which subscribes to the Internet Watch Foundation block list and by implementing appropriate filtering, firewalls and anti-spam software.
- If the school is unclear if a criminal offence has been committed, the Designated Safeguarding Lead will obtain advice immediately through Hampshire Police and/or the Education Safeguarding Team.
- If made aware of IIOC, the school will:
 - Act in accordance with the school's Child Protection and Safeguarding Policy and the Hampshire Safeguarding Children Boards procedures.
 - Immediately notify the school DSL.
 - Store any devices involved securely.
 - Immediately inform appropriate organisations, such as the Internet Watch Foundation (IWF), Hampshire Police or the LADO.
- If made aware that a member of staff or a pupil has been inadvertently exposed to indecent images of children whilst using the internet, the school will:
 - Ensure that the DSL is informed.
 - Ensure that the URLs (webpage addresses) which contain the suspect images are reported to the Internet Watch Foundation via www.iwf.org.uk.
 - Ensure that any copies that exist of the image, for example in emails, are deleted.
 - Report concerns, as appropriate, to parents and carers.
- If made aware that indecent images of children have been found on the school devices, the school will:
 - Ensure that the DSL is informed.
 - Ensure that the URLs (webpage addresses) which contain the suspect images are reported to the Internet Watch Foundation via <u>www.iwf.org.uk</u>.
 - Ensure that any copies that exist of the image, for example in emails, are deleted.
 - Inform the police via 101 (999 if there is an immediate risk of harm) and children's social services (as appropriate).
 - Only store copies of images (securely, where no one else has access to them and delete all other copies) at the request of the police only.
 - Report concerns, as appropriate, to parents and carers.

- If made aware that a member of staff is in possession of indecent images of children on school devices, the school will:
 - Ensure that the Headteacher is informed.
 - Inform the Local Authority Designated Officer (LADO) and other relevant organisations in accordance with the schools managing allegations policy.
 - Quarantine any devices until police advice has been sought.

13.4 Cyberbullying

- Cyberbullying, along with all other forms of bullying, will not be tolerated at Cams Hill School.
- Full details of how the school will respond to cyberbullying are set out in the Anti-Bullying Policy.

13.5 Online Hate

- Online hate content, directed towards or posted by specific members of the community will not be tolerated at Cams Hill School and will be responded to in line with existing school policies, including Anti-Bullying and Good Behaviour Policy.
- All members of the community will be advised to report online hate in accordance with relevant school policies and procedures.
- The Police will be contacted if a criminal offence is suspected.
- If the school is unclear on how to respond, or whether a criminal offence has been committed, the DSL will obtain advice from the LADO and/or Hampshire Police.

13.6 Online Radicalisation and Extremism

- The school will take all reasonable precautions to ensure that children are safe from terrorist and extremist material when accessing the internet in school. Filtering used is IWF compliant.
- If the school is concerned that a child or parent/carer may be at risk of radicalisation online, the DSL and PREVENT Lead will be informed immediately and action will be taken in line with the Child Protection Policy and Safeguarding Policy.
- If the school is concerned that member of staff may be at risk of radicalisation online, the Headteacher will be informed immediately and action will be taken in line with the Child Protection and Safeguarding Policies.
