

## 1. Aims

The school aims to ensure that all personal data collected about staff, pupils, parents, carers, governors, visitors and other individuals is collected, stored and processed in accordance with UK data protection law.

This policy applies to all personal data, regardless of whether it is in paper or electronic format.

This policy does not form part of any employee's contract of employment and we may amend it at any time.

## 2. Legislation and Guidance

This policy meets the requirements of the:

- UK General Data Protection Regulation (UK GDPR) the EU GDPR was incorporated into UK legislation, with some amendments, by <u>The Data Protection, Privacy and Electronic</u> <u>Communications (Amendments etc) (EU Exit) Regulations 2020</u>
- Data Protection Act 2018 (DPA 2018).

It is based on guidance published by the Information Commissioner's Office (ICO) on the <u>UK GDPR</u> and guidance from the Department for Education (DfE) on <u>Generative artificial intelligence (AI) in</u> <u>education</u>.

It meets the requirements of the <u>Protection of Freedoms Act 2012</u> when referring to our use of biometric data. It also reflects the <u>ICO's guidance on CCTV and video surveillance</u> and the <u>Data Sharing: A Code of Practice</u>.

In addition, this policy complies with our funding agreement and articles of association.

## 3. Definitions

## 4. The Data Controller

The school processes personal data relating to parents, carers, pupils, staff, governors, visitors and others, and therefore is a data controller.

The school has paid its data protection fee to the ICO as legally required.

## 5. Roles and Responsibilities

This policy applies to **all staff** employed by our school, and to external organisations or individuals working on our behalf. Staff who do not comply with this policy may face disciplinary action.

#### 5.1 Governing Board

The governing board has overall responsibility for ensuring that our school complies with all relevant data protection obligations.

#### 5.2 Data Protection Lead

The Data Protection Lead (DPL) is responsible for overseeing the implementation of this policy, monitoring our compliance with data protection law, and developing related policies and guidelines where applicable.

They will provide an annual report of their activities directly to the governing board and, where relevant, report to the board their advice and recommendations on school data protection issues.

The DPL is also the first point of contact for individuals whose data the school processes, and for the ICO.

#### 5.3 Headteacher

The Headteacher acts as the representative of the data controller on a day-to-day basis.

#### 5.4 All Staff

All staff are responsible for:

- collecting, storing and processing any personal data in accordance with this policy;
- informing the school of any changes to their personal data, such as a change of address;
- contacting the DPL in the following circumstances:
  - with any questions about the operation of this policy, data protection law, retaining personal data or keeping personal data secure;
  - if they have any concerns that this policy is not being followed;
  - if they are unsure whether or not they have a lawful basis to use personal data in a particular way;
  - if they need to rely on or capture consent, draft a privacy notice, deal with data protection rights invoked by an individual, or transfer personal data outside the UK;
  - if there has been a data breach;
  - whenever they are engaging in a new activity that may affect the privacy rights of individuals;
  - if they need help with any contracts or sharing personal data with third parties.

#### 6. Data Protection Principles

The UK GDPR is based on data protection principles that our school must comply with.

The principles say that personal data must be:

- processed lawfully, fairly and in a transparent manner;
- collected for specified, explicit and legitimate purposes;
- adequate, relevant and limited to what is necessary to fulfil the purposes for which it is processed;
- accurate and, where necessary, kept up-to-date;
- kept for no longer than is necessary for the purposes for which it is processed;
- processed in a way that ensures it is appropriately secure.

This policy sets out how the school aims to comply with these principles.

## 7. Collecting Personal Data

#### 7.1 Lawfulness, Fairness and Transparency

The school will only process personal data where one of six 'lawful bases' (legal reasons) to do so applies, under data protection law:

- The data needs to be processed so that the school can fulfil a contract with the individual, or the individual has asked the school to take specific steps before entering into a contract;
- The data needs to be processed so that the school can comply with a legal obligation;
- The data needs to be processed to ensure the vital interests of the individual or another person, ie to protect someone's life;
- The data needs to be processed so that the school, as a public authority, can perform a task in the public interest or exercise its official authority;
- The data needs to be processed for the legitimate interests of the school (where the processing is not for any tasks the school performs as a public authority) or a third party, provided the individual's rights and freedoms are not overridden;
- The individual (or their parent/carer when appropriate in the case of a pupil) has freely given clear consent.

For special categories of personal data, we will also meet one of the special category conditions for processing under data protection law:

- The individual (or their parent/carer when appropriate in the case of a pupil) has given explicit consent;
- The data needs to be processed to perform or exercise obligations or rights in relation to employment, social security or social protection law;
- The data needs to be processed to ensure the vital interests of the individual or another person, where the individual is physically or legally incapable of giving consent;
- The data has already been made manifestly public by the individual;
- The data needs to be processed for the establishment, exercise or defence of legal claims;
- The data needs to be processed for reasons of substantial public interest as defined in legislation;
- The data needs to be processed for health or social care purposes and the processing is done by, or under the direction of, a health or social work professional or by any other person obliged to confidentiality under law;
- The data needs to be processed for public health reasons, and the processing is done by, or under the direction of, a health professional or by any other person obliged to confidentiality under law;
- The data needs to be processed for archiving purposes, scientific or historical research purposes, or statistical purposes, and the processing is in the public interest.

For criminal offence data, we will meet both a lawful basis and a condition set out under data protection law. Conditions include:

- The individual (or their parent/carer when appropriate in the case of a pupil) has given consent;
- The data needs to be processed to ensure the vital interests of the individual or another person, where the individual is physically or legally incapable of giving consent;
- The data has already been made manifestly public by the individual;
- The data needs to be processed for or in connection with legal proceedings, to obtain legal advice, or for the establishment, exercise or defence of legal rights;
- The data needs to be processed for reasons of substantial public interest as defined in legislation.

Whenever we first collect personal data directly from individuals, we will provide them with the relevant information required by data protection law.

We will always consider the fairness of our data processing. We will ensure we do not handle personal data in ways that individuals would not reasonably expect, or use personal data in ways which have unjustified adverse effects on them.

#### 7.2 Limitation, minimisation and accuracy

We will only collect personal data for specified, explicit and legitimate reasons. We will explain these reasons to the individuals when we first collect their data.

If we want to use personal data for reasons other than those given when we first obtained it, we will inform the individuals concerned before we do so, and seek consent where necessary.

Staff must only process personal data where it is necessary in order to do their jobs.

We will keep data accurate and, where necessary, up-to-date. Inaccurate data will be rectified or erased when appropriate.

Staff should notify us if their personal details change or if they become aware of any inaccuracies in the personal data we hold about them.

In addition, when staff no longer need the personal data they hold, they must ensure it is deleted or anonymised. This will be done in accordance with the Information and Records Management Society's toolkit for schools.

## 8. Sharing Personal Data

We will not normally share personal data with anyone else without consent, but there are certain circumstances where we may be required to do so. These include, but are not limited to, situations where:

- there is an issue with a pupil or parent/carer that puts the safety of our staff at risk;
- we need to liaise with other agencies we will seek consent as necessary before doing this;
- our suppliers or contractors need data to enable us to provide services to our staff and pupils for example, IT companies. When doing this, we will:
  - only appoint suppliers or contractors which can provide sufficient guarantees that they comply with UK data protection law;
  - establish a contract with the supplier or contractor, to ensure the fair and lawful processing of any personal data we share;
  - only share data that the supplier or contractor needs to carry out their service.

We will also share personal data with law enforcement and government bodies where we are legally required to do so.

We may also share personal data with emergency services and local authorities to help them to respond to an emergency situation that affects any of our pupils or staff.

Where we transfer personal data internationally, we will do so in accordance with UK data protection law.

## 9. Subject Access Requests and Other Rights of Individuals

#### 9.1 Subject Access Requests

Individuals have a right to make a 'Subject Access Request' to gain access to personal information that the school holds about them. This includes:

- confirmation that their personal data is being processed;
- access to a copy of the data;
- the purposes of the data processing;
- the categories of personal data concerned;
- who the data has been, or will be, shared with;
- how long the data will be stored for, or if this isn't possible, the criteria used to determine this period;
- where relevant, the existence of the right to request rectification, erasure or restriction, or to object to such processing;
- the right to lodge a complaint with the ICO or another supervisory authority;
- the safeguards provided if the data is being transferred internationally;
- the source of the data, if not the individual;
- whether any automated decision-making is being applied to their data and what the significance and consequences of this might be for the individual.

Subject access requests can be submitted in any form, but we may be able to respond to requests more quickly if they are made using the school's Subject Access Request form which is available on the school's

website (under Statutory Information) to ensure all the necessary details are included. Written requests must include:

- name of individual;
- correspondence address;
- contact number and email address;
- details of the information requested.

If staff receive a subject access request in any form, they must immediately forward it to the DPL.

#### 9.2 Children and Subject Access Requests

Personal data about a child belongs to that child, and not the child's parents or carers. For a parent or carer to make a subject access request with respect to their child, the child must either be unable to understand their rights and the implications of a subject access request or have given their consent.

Children aged 12 and above are generally regarded to be mature enough to understand their rights and the implications of a subject access request. Therefore, the pupil's permission will be needed for most subject access requests from parents or carers. This is not a rule and a pupil's ability to understand their rights will always be judged on a case-by-case basis.

#### 9.3 Responding to Subject Access Requests

When responding to requests, we:

- may ask the individual to provide two forms of identification;
- may contact the individual via phone to confirm the request was made;
- will respond without delay and within one month of receipt of the request (or receipt of the additional information needed to confirm identity, where relevant);
- will provide the information free of charge;
- may tell the individual we will comply within three months of receipt of the request, where a request is complex or numerous. We will inform the individual of this within one month, and explain why the extension is necessary.

We may not disclose information for a variety of reasons, for example if it:

- might cause serious harm to the physical or mental health of the pupil or another individual;
- would reveal that the child is being or has been abused, or is at risk of abuse, where the disclosure of that information would not be in the child's best interests;
- would include another person's personal data that we can't reasonably anonymise, and we don't have the other person's consent and it would be unreasonable to proceed without it;
- is part of certain sensitive documents, such as those related to crime, immigration, legal proceedings or legal professional privilege, management forecasts, negotiations, confidential references, or exam scripts.

If the request is unfounded or excessive, we may refuse to act on it, or charge a reasonable fee to cover administrative costs. We will take into account whether the request is repetitive in nature when making this decision.

When we refuse a request, we will tell the individual why, and tell them they have the right to complain to the ICO or they can seek to enforce their subject access right through the courts.

#### 9.4 Other Data Protection Rights of the Individual

In addition to the right to make a subject access request (see above), and to receive information when we are collecting their data about how we use and process it (see section 7), individuals also have the right to:

- withdraw their consent to processing at any time;
- ask us to rectify, erase or restrict processing of their personal data, (in certain circumstances);
- prevent use of their personal data for direct marketing;
- object to processing which has been justified on the basis of public interest, official authority or legitimate interests;
- challenge decisions based solely on automated decision making or profiling (ie making decisions or evaluating certain things about an individual based on their personal data with no human involvement);
- be notified of a data breach (in certain circumstances);
- make a complaint to the ICO;
- ask for their personal data to be transferred to a third party in a structured, commonly used and machine-readable format (in certain circumstances).

Individuals should submit any request to exercise these rights to the DPL. If staff receive such a request, they must immediately forward it to the DPL.

## 10. Parental Requests to see the Educational Record

As an academy, there is no automatic parental right of access to the educational record. Requests can be made in writing to the Headteacher and will be responded to on a case by case basis.

## 11. Biometric Recognition Systems

Note that in the context of the Protection of Freedoms Act 2012, a "child" means a person under the age of 18.

Where we use pupils' biometric data as part of an automated biometric recognition system (for example, pupils use fingerprints to receive school meals instead of paying with cash), we will comply with the requirements of the <u>Protection of Freedoms Act 2012</u>.

Parents/carers will be notified before any biometric recognition system is put in place or before their child first takes part in it. The school will get written consent from at least one parent or carer before we take any biometric data from their child and first process it.

Parents/carers and pupils have the right to choose not to use the school's biometric system(s). We will provide alternative means of accessing the relevant services for those pupils, eg pupils wishing to use our cashless catering system without using biometrics are given a pin number to use instead.

Parents/carers and pupils can withdraw consent at any time and we will make sure that any relevant data already captured is deleted.

As required by law, if a pupil refuses to participate in, or continue to participate in, the processing of their biometric data, we will not process that data irrespective of any consent given by the pupil's parent(s)/carer(s).

Where staff members or other adults use the school's biometric system(s), we will also obtain their consent before they first take part in it, and provide alternative means of accessing the relevant service if they object. Staff and other adults can also withdraw consent at any time, and the school will delete

any relevant data already captured. Staff data will be removed from the system when they leave the school.

### 12. CCTV

The school uses CCTV in various locations around the school site to ensure it remains safe. We will follow the <u>ICO's guidance on CCTV and video surveillance</u> and comply with data protection principles.

We do not need to ask individuals' permission to use CCTV but we make it clear where individuals are being recorded. Security cameras are clearly visible and accompanied by prominent signs explaining that CCTV is in use.

Any enquiries about the CCTV system should be directed to the Director of IT Systems.

## 13. Photographs and Videos

As part of our school activities, we may take photographs and record images of individuals within our school.

We will obtain written consent from parents/carers for photographs and videos to be taken of their child for communication, marketing and promotional materials.

Where we need parental consent, we will clearly explain how the photograph and/or video will be used to both the parent/carer and pupil. Where we don't need parental consent, we will clearly explain to the pupil how the photograph and/or video will be used.

Any photographs and videos taken by parents/carers at school events for their own personal use are not covered by data protection legislation. However, we will ask that photos or videos with other pupils are not shared publicly on social media for safeguarding reasons, unless all the relevant parents/carers (and pupils where appropriate) have agreed to this.

Where the school takes photographs and videos, uses may include:

- within school on notice boards and in school magazines, brochures, newsletters, etc;
- outside of school by external agencies such as the school photographer, newspapers or campaigns;
- online on our school website or social media pages.

Consent can be refused or withdrawn at any time. If consent is withdrawn, we will delete the photograph or video and not distribute it further.

When using photographs and videos in this way we will not accompany them with any other personal information about the child, to ensure they cannot be identified.

See our Safeguarding Policy and ICT Policy for more information on our use of photographs and videos.

## 14. Artificial Intelligence (AI)

Artificial intelligence (AI) tools are now widespread and easy to access. Staff, pupils and parents/ carers may be familiar with generative chatbots such as ChatGPT and Google Bard. Cams Hill School recognises that AI has many uses to help pupils learn, but also poses risks to sensitive and personal data.

To ensure that personal and sensitive data remains secure, no one will be permitted to enter such data into unauthorised generative AI tools or chatbots.

If personal and/or sensitive data is entered into an unauthorised generative AI tool, Cams Hill School will treat this as a data breach, and will follow the personal data breach procedure outlined in Appendix 1.

## 15. Data Protection by Design and Default

The school will put measures in place to show that we have integrated data protection into all of our data processing activities, including:

- appointing a suitably qualified DPL and ensuring they have the necessary resources to fulfil their duties and maintain their expert knowledge;
- only processing personal data that is necessary for each specific purpose of processing, and always in line with the data protection principles set out in relevant data protection law (see section 6);
- completing data protection impact assessments where the school's processing of personal data presents a high risk to rights and freedoms of individuals, and when introducing new technologies (the DPL will advise on this process);
- integrating data protection into internal documents including this policy, any related policies and privacy notices;
- regularly training members of staff on data protection law, this policy, any related policies and any other data protection matters; we will also keep a record of attendance;
- regularly conducting reviews and audits to test our privacy measures and make sure we are compliant;
- appropriate safeguards being put in place if we transfer any personal data outside of the UK, where different data protection laws will apply;
  - maintaining records of our processing activities, including:
    - for the benefit of data subjects, making available the name and contact details of our school and DPL and all information we are required to share about how we use and process their personal data (via our privacy notices);
    - for all personal data that we hold, maintaining an internal record of the type of data, type of data subject, how and why we are using the data, any third-party recipients, any transfers outside of the UK and the safeguards for those, retention periods and how we are keeping the data secure

## 16. Data Security and Storage of Records

The school will protect personal data and keep it safe from unauthorised or unlawful access, alteration, processing or disclosure, and against accidental or unlawful loss, destruction or damage.

In particular:

- paper-based records and portable electronic devices such as laptops and hard drives that contain personal data are kept under lock and key when not in use;
- papers containing confidential personal data must not be left on office and classroom desks, on staffroom tables, or left anywhere else where there is general access;
- where personal information needs to be taken off site, staff must be aware that it is their responsibility to keep it secure;
- Passwords that are at least ten characters long containing letters and numbers are used to access school computers, laptops and other electronic devices. Where PIN or biometric authentication is available this is used as an acceptable alternative. Staff and pupils are reminded to change their passwords at regular intervals and not reuse passwords from other sites. Staff are also instructed to avoid dictionary words, names and information related to themselves when choosing a password;
- encryption software is used to protect all portable devices and removable media, such as laptops and USB devices;

- staff, pupils or governors who store personal information on their personal devices are expected to follow the same security procedures as for school-owned equipment (see our Code of Conduct, ICT Policy and Staff Acceptable Use of ICT Policy);
- Where we need to share personal data with a third party, we carry out due diligence and take reasonable steps to ensure it is stored securely and adequately protected (see section 8).

## 17. Disposal of Records

Personal data that is no longer needed will be disposed of securely. Personal data that has become inaccurate or out-of-date will also be disposed of securely, where we cannot or do not need to rectify or update it.

For example, we will shred or incinerate paper-based records and overwrite or delete electronic files. We may also use a third party to safely dispose of records on the school's behalf. If we do so, we will require the third party to provide sufficient guarantees that it complies with data protection law.

## 18. Personal Data Breaches

The school will make all reasonable endeavours to ensure that there are no personal data breaches.

In the unlikely event of a suspected data breach, we will follow the procedure set out in Appendix 1.

When appropriate, we will report the data breach to the ICO within 72 hours after becoming aware of it. Such breaches in a school context may include, but are not limited to:

- A non-anonymised dataset being published on the school website which shows the exam results of pupils eligible for the pupil premium;
- safeguarding information being made available to an unauthorised person;
- the theft of a school laptop containing non-encrypted personal data about pupils.

If you consider that the data protection principles have not been followed in respect of personal data about yourself or others you should raise the matter with your Line Manager or the DPL. Any breach of the GDPR will be taken seriously and may result in disciplinary action.

## 19. Training

All staff and governors are provided with data protection training as part of their induction process.

Data protection will also form part of continuing professional development, where changes to legislation, guidance or the school's processes make it necessary.

## 20. Monitoring Arrangements

The DPL is responsible for monitoring and reviewing this policy.

This policy will be reviewed and updated annually and approved by the Resources Committee.

#### 21. Links with Other Policies

This Data Protection Policy is linked to our:

- Freedom of Information Publication Scheme
- Safeguarding Policy
- Staff Code of Conduct
- ICT Policy
- Staff Acceptable Use of ICT Policy

## Appendix 1: Personal Data Breach Procedure

This procedure is based on <u>guidance on UK GDPR personal data breach reporting (DPA 2018)</u> produced by the Information Commissioner's Office (ICO).

- On finding or causing a breach, or potential breach, the staff member, governor or data processor must immediately notify the DPL.
- The DPL will investigate the report, and determine whether a breach has occurred. To decide, the DPL will consider whether personal data has been accidentally or unlawfully:
  - lost;
  - stolen;
  - destroyed;
  - altered;
  - disclosed or made available where it should not have been;
  - made available to unauthorised people.
- Staff and governors will cooperate with the investigation (including allowing access to information and responding to questions). The investigation will not be treated as a disciplinary investigation.
- If a breach has occurred or it is considered to be likely that is the case, the DPL will alert the Headteacher and the Chair of Governors.
- The DPL will make all reasonable efforts to contain and minimise the impact of the breach, assisted by relevant staff members or data processors where necessary and the DPL should take external advice when required. (Actions relevant to specific data types are set out at the end of this procedure).
- The DPL will assess the potential consequences, (based on how serious they are, and how likely they are to happen) before and after the implementation of steps to mitigate the consequences.
- The DPL will work out whether the breach must be reported to the ICO and the individuals affected. This must be judged on a case-by-case basis. To decide, the DPL will consider whether the breach is likely to negatively affect people's rights and freedoms and cause them any physical, material or non-material damage (eg emotional distress), including through:
  - loss of control over their data;
  - discrimination;
  - identify theft or fraud;
  - financial loss;
  - unauthorised reversal of pseudonymisation (for example, key-coding);
  - damage to reputation;
  - loss of confidentiality;
  - any other significant economic or social disadvantage to the individual(s) concerned.

If it's likely that there will be a risk to people's rights and freedoms, the DPL must notify the ICO.

- The DPL will document the decisions (either way), in case the decisions are challenged at a later date by the ICO or an individual affected by the breach. Documented decisions are stored securely in an access controlled folder on Sharepoint.
- Where the ICO must be notified, the DPL will do this via the <u>'Report a breach' page of the ICO website</u> or through their breach report helpline (0303 123 1113) within 72 hours of the school's awareness of

the breach. As required, the DPL will set out a description of the nature of the personal data breach including, where possible:

- the categories and approximate number of individuals concerned;
- the categories and approximate number of personal data records concerned;
- the name and contact details of the DPL;
- a description of the likely consequences of the personal data breach;
- a description of the measures that have been, or will be taken, to deal with the breach and mitigate any possible adverse effects on the individual(s) concerned.

If all the above details are not yet known, the DPL will report as much as they can within 72 hours of the school's awareness of the breach. The report will explain that there is a delay, the reasons why and when the DPL expects to have further information. The DPL will submit the remaining information as soon as possible.

- The DPL will also assess the risk to individuals, again based on the severity and likelihood of potential or actual impact. If the risk is high, the DPL will promptly inform, in writing, all individuals whose personal data has been breached. This notification will set out:
  - a description, in clear and plain language, of the nature of the personal data breach;
  - the name and contact details of the DPL;
  - a description of the likely consequences of the personal data breach;
  - a description of the measures that have been, or will be, taken to deal with the data breach and mitigate any possible adverse effects on the individual(s) concerned.

As above, any decision on whether to contact individuals will be documented by the DPL.

- The DPL will consider, in light of the investigation and any engagement with affected individuals, whether to notify any relevant third parties who can help mitigate the loss to individuals for example, the police, insurers, banks or credit card companies.
- The DPL will document each breach, irrespective of whether it is reported to the ICO. For each breach, this record will include the:
  - facts and cause
  - effects
  - action taken to contain it and ensure it does not happen again (such as establishing more robust processes or providing further training for individuals).

Records of all breaches will be stored securely in an access-controlled folder on Sharepoint.

- The DPL and Headteacher will meet to review what happened and how it can be stopped from happening again. This meeting will happen as soon as reasonably possible.
- The DPL and Headteacher will meet regularly to assess recorded data breaches and identify any trends or patterns requiring action by the school to reduce risks of future breaches.

#### Actions to minimise the impact of data breaches

The school sets out below the steps we might take to try and mitigate the impact of different types of data breach if they were to occur, focusing especially on breaches involving particularly risky or sensitive information. The school will review the effectiveness of these actions and amend them as necessary after any data breach.

#### Sensitive information being disclosed via email (including safeguarding records)

- If special category data (sensitive information) is accidentally made available via email to unauthorised individuals, the sender must attempt to recall the email as soon as they become aware of the error;
- Members of staff who receive personal data sent in error must alert the sender and the DPL as soon as they become aware of the error;
- If the sender is unavailable or cannot recall the email for any reason, the DPL will ask the IT Technical Team to attempt to recall it from external recipients and remove it from the school's email system and/or the external recipient will be asked to delete the email from their inbox;
- In any cases where the recall is unsuccessful or cannot be confirmed as successful, the DPL will consider whether it is appropriate to contact the relevant unauthorised individuals who received the email, explain that the information was sent in error, and request that those individuals delete the information and do not share, publish, save or replicate it in any way;
- The DPL will endeavour to obtain a written response from all the individuals who received the data, confirming that they have complied with this request;
- The DPL will carry out an internet search to check that the information has not been made public; if it has, we will contact the publisher/website owner or administrator to request that the information is removed from their website/other platform and deleted.
- If safeguarding information is compromised, the DPL will inform the designated safeguarding lead and discuss whether the school should inform any, or all, of its local safeguarding partners.
